### Cancellation

I understand that as a member of the University Club I will be required to retain membership for 6 months after initiation. There is a 30 day trial period, during which membership may be cancelled. I understand that if I wish to cancel this membership after the 6 month period, I must submit this request in writing. I further understand that if this request for cancellation is received before the 15<sup>th</sup> and there are no charges on the account for the month, that I am not obligated to pay the current month's dues. Yet, if the request for cancellation is received after the 15<sup>th</sup> of the month and/or there are charges on the account, I may not cancel until the balance is paid in full. I will also be responsible for paying the current month's dues. I understand that memberships less than one year old will be retrospectively charged rental fees if they are cancelled within 6 months of the event. Once cancellation is official, I will receive a confirmation letter by mail.

### Dress Code

Late Fees

I understand that the complete balance of my account is due on the 25th of each month. I understand that late charges will be applied to delinquent accounts with balances of \$50 or more. Late fees are a flat fee and will be charged at 30, 60 and 90 days delinquent. Late fees are \$10, \$20 and \$30, respectively. I understand that my membership will be suspended if it reaches 90 days delinquent and cancelled after 120 days. I further understand that after 120 days delinquent the account will be turned over to the University of Alabama Collections Department.

Returned Checks

I understand that University Club members will be charged a \$30 fee for all returned checks. I understand that members are responsible for their guests returned checks. Denied bank drafts will also be subject to the returned check fee.
